



Acronym	Meaning
ETSF External Temporary Storage Facility	ETSF is a temporary storage facility which is situated inside or outside the approved area of a sea or airport, where imported goods may be placed into storage prior to being placed under a customs procedure or reexported
BIRDS Bulk Import Reduced Data Set	This customs simplification allows you to declare two or more low value parcel into a single import declaration. It also requires a reduced data set compared to a standard full import declaration
AICES Association of International Couriers & Express Services	AICES members offer UK importers and exporters the services they need to trade competitively post-Brexit transition and comply with the new customs controls.
Authorised Consignee	An authorised consignee is a person or an organisation who is authorised to accept goods in transit without submitting the transit declaration to the customs office at the destination. The granting of the status of authorised consignee simplifies the customs procedure.
Transit Document – T1 Discharge	A T1 is a transit document which allows for goods which originated outside the European Union to move freely within the European Union. The main benefit is that no customs duties or taxes are payable as the shipment moves from one country to the next within the European Union.
Devanning	Devanning in the shipping industry is the process of unloading the inbound cargo from a shipping container.
